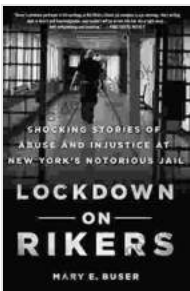

The Case of Kalief Browder

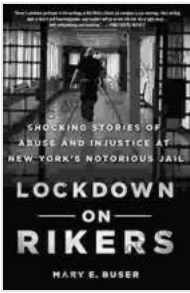
